1. Call to Order and Roll Call

2. Approval of Minutes

Crystal Lauderdale advised this would be possible and she will look into this as a possible update to the website. She also advised that the recruiters were planning a google hangout (virtual question and answer session) at the end of February 2014.

Crystal Lauderdale gave an update on the branding process.

6. Recruiting Update

Dr. Darkazalli gave an update on the recruiting numbers. He advised that tours of the Florida Poly campus are being conducted daily. The students who have paid their deposits have an average GPA of 3.9 and an average SAT of 1850.
