1 9.5 **Notice of Proposed Disciplinary Action.** 2 When the President or designee has reason to believe that a suspension or (a) 3 termination should possibly be imposed as a disciplinary consequence, the 4 President or designee shall provide the employee with a written Notice of Proposed 5 Disciplinary Action and the rationale for such action. 6 Such Notice shall be sent certified mail, return receipt requested, to the employee's **(b)** 7 last known address, delivered to the employee in person, or e-mailed to the 8 employee's university e-mail address. 9 In the event that the University reasonably believes that the employee's actions or (c) presence on the job would adversely affect the orderly conduct and processes of the 10 11 University, and/or jeopardize the safety or welfare of the employee, faculty and 12 staff, or students, the employee may be placed on paid administrative leave pending 13 the outcome of a proposed disciplinary action.
