1. Question: No mention is made of steps, decks, ramps for the new modular office buildings requisition. Please clarify if these are to be quoted.
Response:
 - a. Please include ramps at the front entry, and steps at the back entry of each trailer.
 - b. Combined ramp options will also be considered. Please include these as a separate line item (add alternate) to the bid.

2. Question: It is assumed that according to the drawings, only the solid/shaded lines represent actual walls to be placed. The other partitions are to be cubicles? If so, is the provision of cubicles part of the solicitation? Please clarify.
Response:
 - a. Solid walls are full height walls, and all other walls are half height walls.

3. Question: On page 1 of the solicitation packet it is referenced that bid due date is May 1, 2024 2:00 PM. On page 3, par. 8 of the same document it is referenced proposal submission deadline to be April 17 at 2:00 PM. Please clarify.
Response:
 - a. Bid due date is: May 1, 2024 2:00 PM. Page 3, Section 8 Proposal submission and Deadline should read: Offeror must provide one (1) electronic copy of your proposal to procurement@floridapoly.edu. The Proposal and any copies must be submitted prior to 2:00 PM(ET); May 1, 2024, 2:00 PM

4. Question: Attachment A / TSM modular drawing is missing a second entrance/exit door. This has to be addressed.
Response:
 - a. The University has updated Attachment A to include another door.

5. Question: #8 Proposal Submission and Deadline – States that the proposal needs to be submitted prior to 2:00 pm on April 17, 2024. Please clarify this should be May 1, 2024.

6. Question: Attachment A,B, & C – Please show solid walls and what looks like half (48" AFF) walls. Are we to provide the half walls as shown?

7. Question: Is there an anticipated award date? With a deadline for installation, it would be helpful to know when the university intends to award or issue a letter of intent.

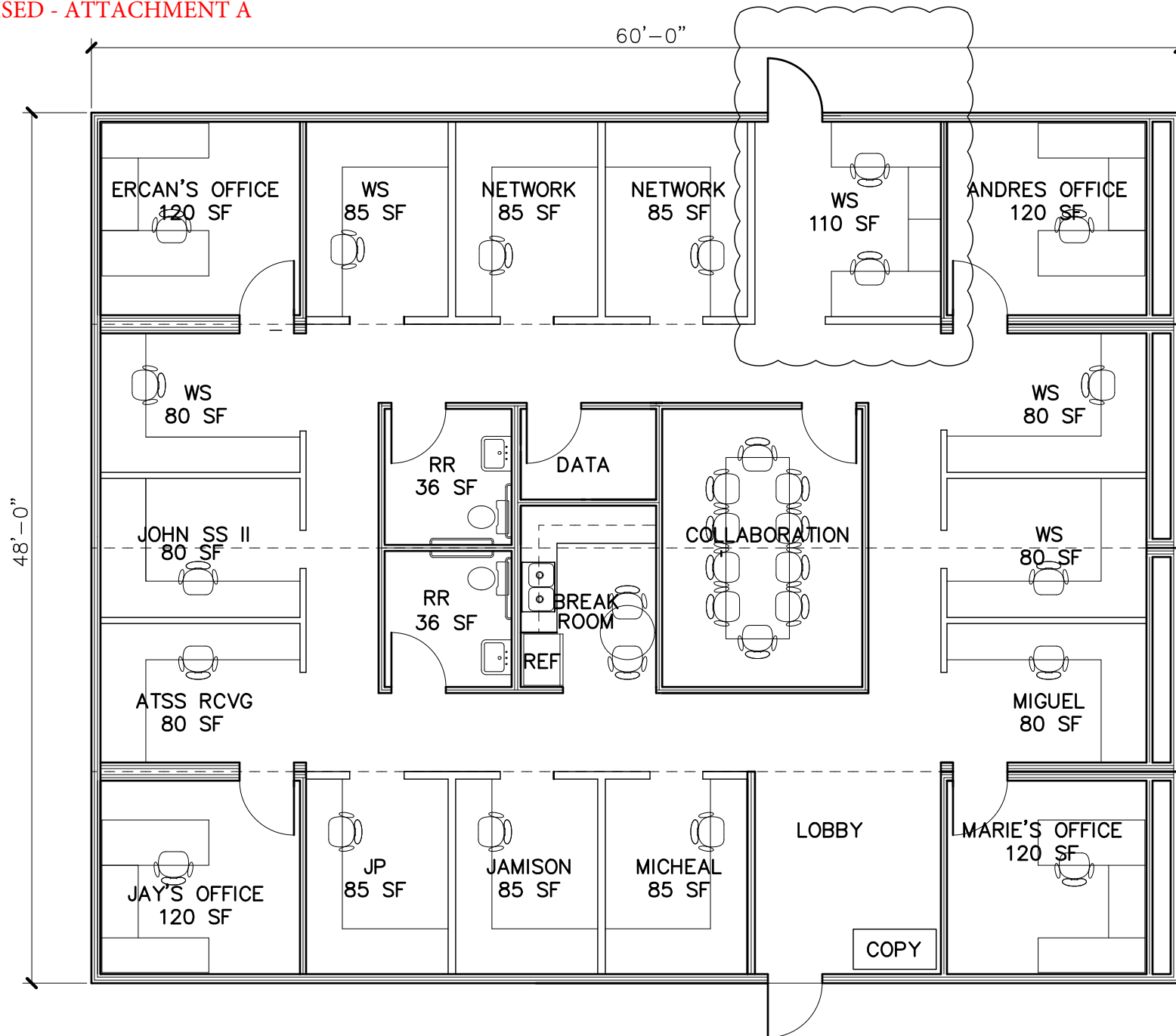
