B. Describe in lay language, what the item/service is and how it is to be used.

Temporary housing solution to accommodate an increase in student enrollment at Florida Poly.

C. What feature or special condition of this commodity/service is unique or cannot be obtained from any other source?

The University issued ITN 22-016 for Temporary Student Housing in late February, 2022 and received no responsive responses. Due to transportation and travel logistics, the University requires the property to be within twenty (20) miles from Florida Polytechnic Main Campus, 4700 Research Way, Lakeland, Florida.

Student Housing is our current, primary driver for enrollment and the University's current housing facilities are unable to accommodate the number of students that desire to attend the University in the upcoming semester. Of note, the University is in the process of awarding a student housing developer from a public solicitation (ITN 22-022) for additional, on-campus student housing, however overflow housing is required for immediate use until new on-campus housing is brought online in 2024.

- D. Is this product being purchased directly from the manufacturer? If No, is it available from more than one dealer? If Yes, it is available from more than one dealer, why can this item not be bid?

- E. Prior to submitting this requisition, did you investigate other possible sources? Yes.
  - 1. The University issued ITN 22-016 for Temporary Student Housing in late February, 2022 and received no responsive responses.
  - 2. Florida Poly Office of General Counsel reached out to the State for advice and due to the critical need, the State advised to issue a sole source for this project.

- 3. The University learned of a new complex opening up 2 miles from campus. The complex had enough units available to assist Florida Poly with off-campus university housing.
- 4. There is a shortage of rental housing in the area. Due to time restraints, the University does not have the chance to go out and duplicate the competitive solicitation process without risking losing available, safe and quality units.
